

#### Transcript of 2493.4

The foregoing Accounts of Charge and Discharge of Alexander MacCulloch Factor for Sir John Ross of Balnagown Baronet, his Intromissions with the Rents of the said Estate of Balnagown for the Crops and years after mentioned, and the produce of the Farms in the said Sir John Ross's own possession vizt. The victual Rents of the Estate and victual produce of the Farms Crop and year Seventeen hundred and Seventy nine, not formerly accounted for, and the whole Rents of the said Estate and produce of said Farms Crop and year Seventeen hundred and Eighty, Including the Arrears of Tenants Credited in former accounts, Consisting of Forty five pages, The Rents and Farms Produce of Crop Seventeen hundred and Eighty one, Consisting of Forty seven pages, The Rents & Farms produce of Crop and year Seventeen hundred and Eighty two Consisting of forty six pages, The Rents and Farms produce of Crop and year Seventeen hundred and Eighty three Consisting of Forty four pages, and the Rents and Farms produce of Crop and year Seventeen hundred and Eighty four Consisting of Fifty two pages, All signed of this date having been Examined by the said Sir John Ross and Alexander MacCulloch they find the same to be fairly stated and Sufficiently Instructed, and therefore they approve thereof, They also find that upon the whole there is a Balance of Six hundred and forty four pounds, Eight shillings and Seven Twelfths of a penny Sterling of Money, and One thousand and Sixty two Bolls and two pecks of victual arising upon the said Accounts, not Charged against the said Alexander MacCulloch, with both which he is to charge himself in his next Account., They further find that the Arrears due by Tenants for Crop and year one thousand seven hundred and eighty four, and Debts outstanding at Martimas [sic] one thousand seven hundred and eighty four Credited to the Factor amount to Three thousand nine hundred and ninety two pounds thirteen shillings, and one penny, Six Twelfths of a penny Sterling with which the said Alexander MacCulloch is also to Charge himself in his next Account, and the Vouchers of the saids Accounts having been delivered up, The saids Sir John Ross and Alexander MacCulloch hereby mutually discharge each other of the whole Articles contained in the saids Accounts, the forsaid Balances and Arrears Excepted; And the said Sir John Ross having Considered the said Alexander MacCulloch's attention in the management of the said Estate, and in the Improvements thereof Carried on under his direction, a great part of which was during Sir John's absence for several years in the Publick Service, He the said Alexander MacCulloch, in Consideration of his said Services, and also in order that he may be Indemnified of any Losses which he may have sustained in the aforsaid management since he became Factor on the said Estate of Balnagown is hereby Authorised to take Credit in the account of his Intromissions for Crop and year Seventeen hundred & Eighty five for the Sum of one hundred pounds Sterling, and for the like Sum of one hundred pounds Sterling in his Accounts for Crop and year Seventeen hundred and Eighty Six, and that over and above his usual Sallary, In witness whereof this Docquet written upon Stamp paper by John Buchan writer in Edinburgh, and another Exact Duplicate thereof are Subscribed by the saids Sir John Ross and Alexander MacCulloch at Edinburgh the Eighteenth day of January one thousand seven hundred and Eighty seven years Before these witnesses David Ross Secretary to the General Post Office at Edinburgh and James Baillie of Coulterallers writer in Edinburgh, witnesses also to Signing the marginal note.
